#### **DISTRIBUTION OF SHARES BY THE CONTROLLING SHAREHOLDER**

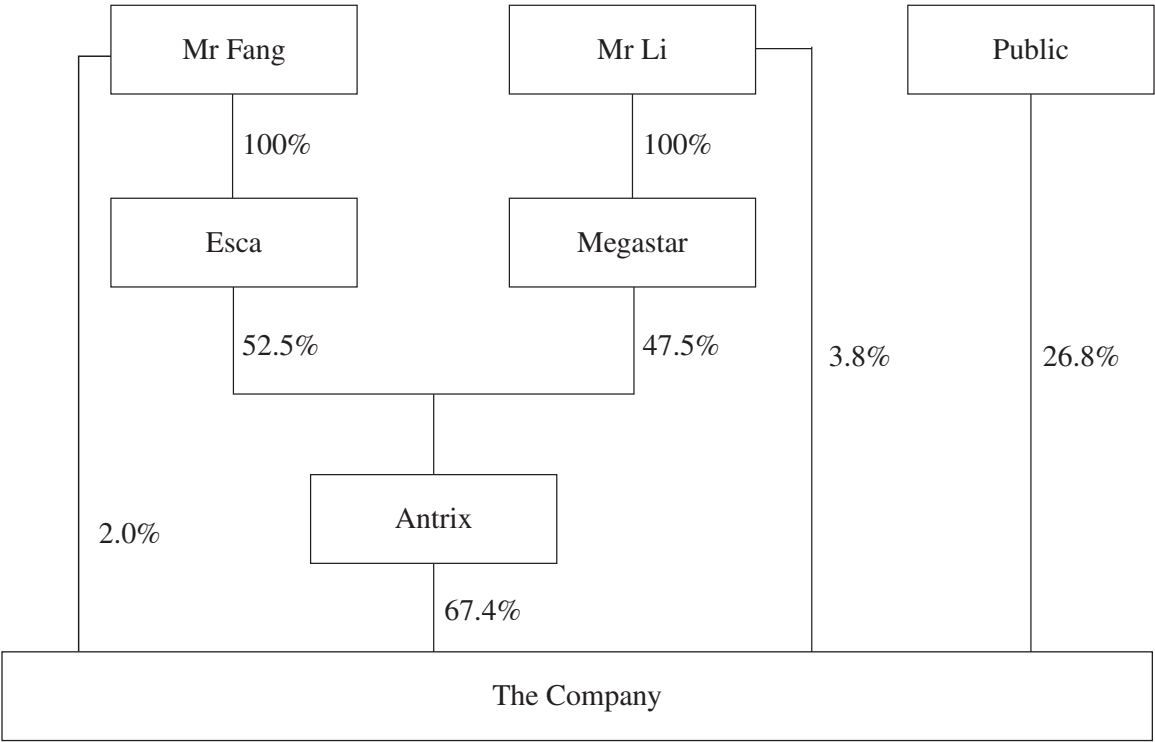
This announcement is made by the Company pursuant to Rule 13.09 of the The Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and the Inside Information Provisions under Part XIV A of the Securities and Futures Ordinance.

The Company has been informed by Antrix, the controlling shareholder of the Company, that on 10 August 2015, Antrix distributed 67,692,368 Shares, representing approximately 6.7% of the issued share capital of the Company, to Megastar, one of the two shareholders of Antrix. At the instruction of Megastar, the 67,692,368 Shares were transferred directly from Antrix to Mr Li, the sole shareholder of Megastar.

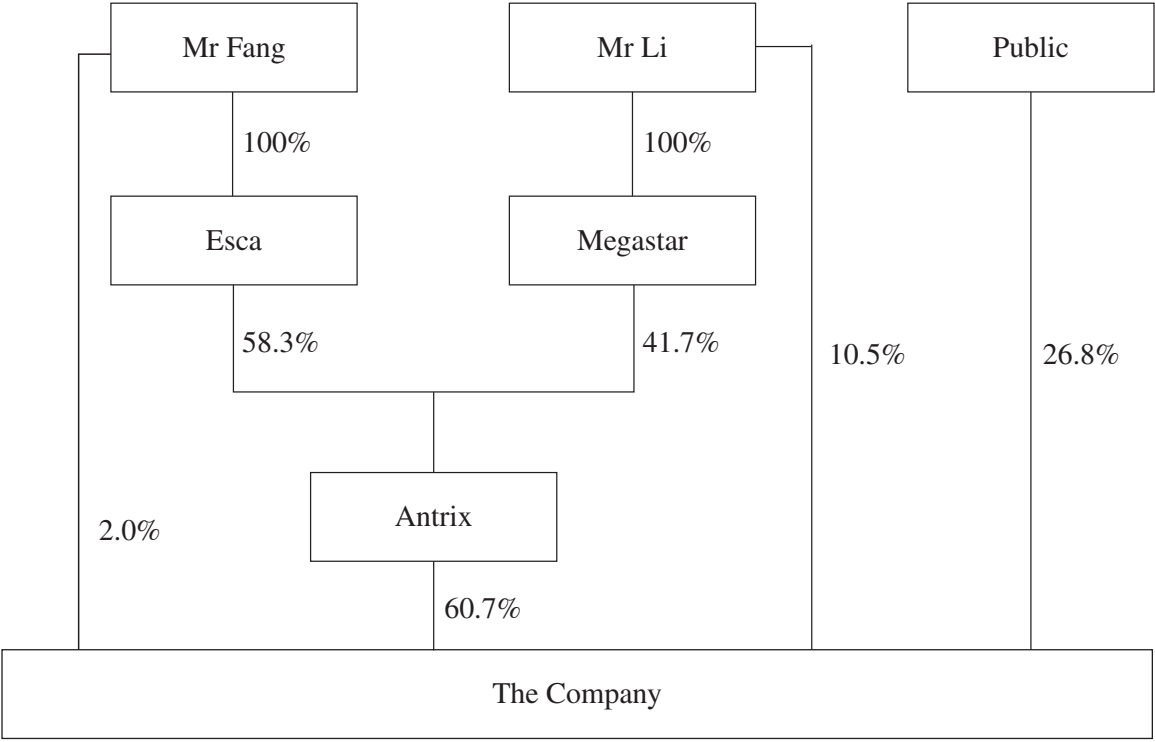
Immediately before the Distribution, Antrix held 677,692,368 Shares. Immediately after the Distribution, Antrix holds 610,000,000 Shares.

The Company was further informed by Antrix that, on 10 August 2015, Megastar transferred 5.8% of the beneficial interest in Antrix to Esca, the other shareholder of Antrix.
