### **UNAUDITED RESULTS OF SUZHOU QINGYUE FOR THE QUARTER ENDED 31 MARCH 2024**

This announcement is made by the Company pursuant to Rule 13.09 of the Listing Rules and the Inside Information Provisions under Part XIVA of the SFO.

Suzhou QingYue, an associated company of the Group in which the Group has an equity interest of about 28.08%, announced on 29 April 2024 its unaudited results for the quarter ended 31 March 2024. The loss attributable to the owners of Suzhou QingYue for the quarter ended 31 March 2024 amounted to approximately RMB8 million (equivalent to approximately HK\$9 million), as compared with a profit attributable to the owners of Suzhou QingYue of approximately RMB4 million for the quarter ended 31 March 2023.
